

**ARDEN ANGLICAN SCHOOL COUNCIL ORDINANCE AMENDING ORDINANCE 1989**

No 24, 1989

**AN ORDINANCE to amend the Arden Anglican School Council Ordinance 1962.**

**WHEREAS**

A. Arden Anglican School Council (hereinafter referred to as "the School") is constituted a body corporate and is regulated by the provisions of the Arden Anglican School Council Ordinance 1962. ("the Principal Ordinance").

B. The School wishes to amend its Constitution to broaden its investment powers and to increase its borrowing limit.

C. The School also wishes to make certain miscellaneous amendments to its Constitution for the purposes of updating its Constitution.

D. It is expedient that the Constitution for the School be amended with respect to the above matters.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:

1. This Ordinance may be cited as "Arden Anglican School Council Ordinance Amending Ordinance 1989".

2. The Principal Ordinance is amended as follows:

- (a) by omitting from the short title the words "now carried on by the Council for the Promotion of Sydney Anglican Diocesan Schools";
- (b) by omitting from clause 2 the matter "(i)" and "(ii)" and by inserting instead "(a)" and "(b)" respectively;
- (c) by omitting from clause 3 the matter "(a)" and "(b)" and by inserting instead "(1)" and "(2)" respectively;
- (d) by omitting clause 5;
- (e) by omitting from clause 9 the matter "(a)" and "(b)" and by inserting instead "(1)" and "(2)" respectively;
- (f) by omitting from paragraph 8(a) the words and figures "Three hundred and fifty thousand dollars (\$350,000.00) and by inserting instead the words and figures "Five hundred thousand dollars (\$500,000)";
- (g) by omitting clauses 13 and 14;
- (h) by omitting from clause 15 the words "and at the same time present a statement of Income and Expenditure and a Balance Sheet duly audited showing the financial position of the School";
- (i) by omitting from clause 16 the words "as amended from time to time";
- (j) by omitting from clause 17 the matter "(a)" and "(b)" and by inserting instead "(1)" and "(2)" respectively;

- (k) by omitting from clause 17 the words "Church of England in" and inserting instead "Anglican Church of" where secondly appearing;
- (l) by omitting from clause 17 the words "Church of England" and inserting "Anglican Church of Australia";
- (m) by omitting from clause 18 the matter "-1981";
- (n) by omitting from clause 19 the matter "1954 (No 39 of 1954)" and by inserting "1975"; and
- (o) by omitting from clause 20 the matter "-1981".
