
Assessment Authorisation Amendment Ordinance 1978

No. 32, 1978

AN ORDINANCE to amend the Assessment Authorisation Ordinance 1975-1977.

WHEREAS it is desirable to specify the basis on which money derived from the conduct of a kindergarten or child care centre on church trust property in the Diocese of Sydney is to be included in the gross receipts of a parochial unit for the purposes of the Assessment Authorisation Ordinance 1975-1977 (hereinafter called the "Principal Ordinance") NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) This ordinance may be cited as the "Assessment Authorisation Amendment Ordinance 1978".

(2) The Principal Ordinance as amended by this ordinance may be cited as the "Assessment Authorisation Ordinance 1975-1978" and in any reprint of the Principal Ordinance clause 1(1) shall be amended accordingly.

2. The Principal Ordinance is amended:—

(a) by omitting from paragraph (h) of clause 3 the word "and" where secondly occurring;

(b) by inserting at the end of paragraph (i) of clause 3 the word "; and";

(c) by inserting after paragraph (i) of clause 3 the following paragraph:—

"(j) where a kindergarten or child care centre is conducted on church trust property within the parochial unit:—

(i) where a fair and reasonable donation or other payment is made to or for the benefit of the parochial unit in respect of the use of that property by the kindergarten or child care centre — the amount of that donation or payment;

(ii) where no such donation or payment is made — such amount as would be equal to the fair and reasonable annual rental value of that property (whether or not rent is actually paid to or for the benefit of the parochial unit in respect of the conduct of the kindergarten or child care centre);"

(d) by omitting from the proviso to clause 3 the matter "(g)" and by inserting instead the matter "(j)";

(e) by re-numbering paragraphs (h), (i), (j), (k) and (l) of the proviso to clause 3 as paragraphs (i), (ii), (iii), (iv) and (v) respectively.

3. The amendments made to the Principal Ordinance by clause 2 of this ordinance shall take effect on and from 1st January 1979.
