*Church of England National Emergency Fund ("Rathane")  
Variation of Trust Ordinance 1961.*

No. 47, 1961.

AN ORDINANCE to vary the trusts upon which certain land and premises known as "Rathane" at Port Hacking in the Shire of Sutherland is held and purposes incidental thereto.

WHEREAS Church of England Property Trust, Diocese of Sydney (hereinafter called the Corporate Trustee) is registered as proprietor in fee simple of the land comprised in Certificate of Title Volume 5932 Folio 163 more particularly described in the Schedule hereto AND WHEREAS by Declaration of Trust dated 7th April 1949 the Corporate Trustee declared that it held the said land upon trust for the Church of England National Emergency Fund in the Diocese of Sydney (hereinafter referred to as C.E.N.E.F.) to be used and applied for such purposes of that Fund as long as the Council thereof might so require or determine or in default of such requirement or determination for the use benefit or purposes of the Church of England in the Diocese of Sydney as the Synod might by Ordinance determine AND WHEREAS the Board of Management of C.E.N.E.F. as constituted by Ordinance No. 29, 1958 by virtue of the provisions of such Ordinance now takes the place of the former Council of C.E.N.E.F. AND WHEREAS the said land and premises have been used for many years as a centre for youth leadership and the furtherance of youth work and have been kept and maintained by the Youth Department of the Diocese of Sydney at its own expense and such Department now proposes to make certain improvements alterations and additions thereto AND WHEREAS the said Board has resolved that the said land and premises should henceforth be under the management and control of the Council of the Youth Department in the Diocese of Sydney as constituted under the provisions of the "Youth Department Ordinance 1949" and that the said land and premises be held by the Corporate Trustee for the said Youth Department as an asset thereof for the purposes set out in such Ordinance NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS AND DIRECTS as follows:-

1. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the said land is held it is inexpedient to carry out and observe the same to the extent to which they are hereby varied and it is expedient to vary such trusts accordingly.

2. The Corporate Trustee shall henceforth hold the said land upon trust for the Department of Youth in the Diocese of Sydney for the purposes and in accordance with the provisions of the Youth Department Ordinance 1949 or any Ordinance or Ordinances amending the same.

3. This Ordinance may be cited as "Church of England National Emergency Fund ("Rathane") Variation of Trust Ordinance 1961."

**THE SCHEDULE.**

All that piece or parcel of land situated at Port Hacking in the Shire of Sutherland Parish of Wattamolla County of Cumberland containing 2 roods 25½ perches being Lot B in plan annexed to Order D756329 and being the whole of the land in Certificate of Title Volume 5932 Folio 163 upon which are erected buildings known as "Rathane."
