

CHURCH OF ENGLAND PROPERTY TRUST DIOCESE OF SYDNEY
(SMALL ACCOUNTS) ORDINANCE 1976

No. 26 1976

AN ORDINANCE to provide for the management and use of certain church trust property and to vary the trusts on which some of this property is held.

WHEREAS Church of England Property Trust Diocese of Sydney (hereinafter called the "Corporate Trustee") is the trustee of all of the amounts (or of the investments representing the same) specified in part one of the schedules to this ordinance AND WHEREAS each amount specified in part one of a schedule to this ordinance is held (or is believed to be held) upon the trusts set forth in part two of that schedule AND WHEREAS the income from each amount specified in part one of a schedule to this ordinance (or from the investments representing the same) is subject to the direction (if any) set forth in part three of that schedule AND

WHEREAS the cost of maintaining accounts in respect of each of the said amounts exceeds or is a substantial part of the income derived from the said amounts AND WHEREAS it is expedient that other provision be made for the management and use of the said amounts and the income therefrom and that the trusts on which each of the said amounts are held be varied to the extent hereinafter provided NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS RULES DECLARES AND DIRECTS as follows:-

1. By reason of circumstances which have arisen subsequent to the creation of the trusts on which each of the amounts (or the investments representing the same) specified in part one of the schedules to this ordinance are held it is inexpedient to carry out the same to the extent to which the same are hereby varied.

2. All moneys and other property which have been held upon the trusts set forth or referred to in parts two and three of each schedule and which have been applied or are being applied in any manner inconsistent with those trusts shall be deemed to have been held upon trusts for the purposes for which the same have been applied or are being applied.

3. Each amount specified in part one of the schedules to this ordinance and all income thereon which (whether before or after this ordinance is assented to) has not been distributed by the Corporate Trustee shall be paid (unless, in part four of the schedule, the Corporate Trustee is directed to retain the same) to the person persons or corporation named or described in part four of that schedule and shall be applied by the payee for the purposes set forth in part five of that schedule provided that, where the amount has been invested, the Corporate Trustee may either realise the investments immediately or on some date which the Corporate Trustee considers appropriate (and either in one lot or in several lots) and pay the proceeds of such realisation (after meeting all costs thereof) in lieu of the said amount or transmit the investments to the said person, persons or corporation.

4. This ordinance may be cited as "Church of England Property Trust Diocese of Sydney (Small Accounts) Ordinance 1976".
