

**The Constitutions Amendment Ordinance 1984
Assenting Ordinance 1984**

No. 29, 1984

AN ORDINANCE to adopt a certain ordinance of the Provincial Synod.

WHEREAS

5 A. The Provincial Synod of New South Wales passed an Ordinance entitled "The Constitutions Amendment Ordinance 1984" on the 29th day of February 1984.

B. A copy of the Provincial Synod Ordinance is printed in the Schedule to this Ordinance.

10 NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:

1. This Ordinance may be cited as "The Constitutions Amendment Ordinance 1984 Assenting Ordinance 1984".

2. The Synod hereby assents to the said Ordinance and consents to the amendments therein.

SCHEDULE

THE CONSTITUTIONS AMENDMENT ORDINANCE 1984

AN ORDINANCE to amend the Schedule to the Anglican Church of Australia Constitutions Act, 1902.

20 WHEREAS it is expedient that Article 14 of the Schedule to the Anglican Church of Australia Constitutions Act, 1902 be amended, NOW the Provincial Synod in the Province of New South Wales HEREBY ORDAINS as follows:

1. Article 14 of the Schedule to the Anglican Church of Australia Constitutions Act, 1902 is hereby amended:

(a) by the omission of the word "The" at the beginning and by the insertion in lieu thereof of the words "Subject to the terms of this clause, the";

(b) by the omission of the words "holding distinct official positions in the Diocese" and by the insertion in lieu thereof of the words "who (not being entitled to be summoned by virtue of any other provision hereof) are duly authorised or licensed to officiate by the Bishop"; and

(c) by the insertion of the following words at the end thereof: "and provided further that the Synod of a Diocese may, by ordinance, regulate the exercise by the Bishop of his powers pursuant to this provision".

2. The heading which precedes Article 28 of the said Schedule is hereby amended by the substitution of the words "Metropolitan or Primate" for the words "Archbishop of Canterbury".

- 3. The amendments effected by clause 1 shall apply in each Diocese in relation to the new Synod next elected and convened (and each Synod thereafter) after this amendment takes effect.
- 4. This Ordinance shall come into operation on a date designated by the Metropolitan being a date after the Synod of each Diocese in the Province has adopted these amendments and the amendments have been ratified by canon of the General Synod of the Church. 5
- 5. This ordinance may be cited as "The Constitutions Amendment Ordinance 1984".
