

AN ORDINANCE to vary the trusts on which certain property is held.

WHEREAS

- A. The Endowment of the See Ordinance 1977 (hereinafter called "the Principal Ordinance") provides for certain property described therein to be held upon the trusts specified in the Seventh Schedule thereto.

- B. It is expedient that the trusts set out in the said Seventh Schedule be amended to enable the Endowment of the See Committee at the request of the Archbishop to expend funds up to a specified limit within any one year without prior approval of the Standing Committee of the Synod of the Diocese of Sydney.

- C. By reason of circumstances which may have arisen subsequent to the creation of the trusts specified in the Seventh Schedule of the Principal Ordinance it is inexpedient to carry out and observe the same to the extent that the same are hereby varied.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS as follows:-

1. By reason of circumstances which have arisen subsequent to the creation of the trusts specified in the Seventh Schedule of the Principal Ordinance it is inexpedient to carry out the same to the extent that the same are hereby varied.

2. (1) The Principal Ordinance is amended by the insertion in Clause 4 of a new subclause as follows:

"(5) As soon as practicable after the expiration of each calendar year the Committee shall report to the Standing Committee the total amount expended pursuant to paragraph (d) of the Seventh Schedule."

- (2) The Seventh Schedule of the Principal Ordinance is hereby amended by:

- (a) The insertion of a new paragraph. (d) as follows:

"(d) Subject as aforesaid to pay such other amounts not exceeding \$10,000 <sup>in the year 1983 and in each subsequent calendar year</sup> ~~per annum~~ or such greater amount per annum as may be determined from time to time by resolution of the Standing Committee on or towards such purposes of the Anglican Church of Australia in the Diocese of Sydney as may from time to time be specified by the Archbishop".

- (b) The relettering of paragraph (d) as "(e)".

- (c) The deletion of the words "these provisions" where they appear after the lettered paragraphs and the insertion

instead of the words "paragraphs (a), (b) and (c)".

2. ~~(c) Subject as aforesaid to pay such other amounts not exceeding \$10,000.00 per annum or such greater amount per annum as may be determined from time to time by resolution of the Standing Committee on such expenses in connection with the Diocese as may be from time to time requested by the Archbishop. As soon as practicable after the expiration of each calendar year the Endowment of the See Committee shall report to the Standing Committee the total amount expended under this provision.~~


(d) Subject as aforesaid to pay such other amounts in connection with the Diocese for such purpose as may from time to time be determined.

(e) Subject as aforesaid to pay such amounts for such purposes of the Diocese beyond the Diocese as may be determined by resolution of Synod or by ordinance of Standing Committee by only insofar as those purposes include the provision of a capital sum to endow the see of another diocese.

Except for amounts to be paid pursuant to sub-clause (c) all other amounts to be paid pursuant to these provisions shall be such as are from time to time determined by the Standing Committee and in the case of payments made under paragraphs (a) and (d) approved by the Archbishop and in the case of payments under paragraph (b) approved by the Archbishop or his Commissary or Administrator as the case may be."


3. The Principal Ordinance as amended by this ordinance may be cited as the "Endowment of the See Ordinance 1977-1983" and in any reprint of that Ordinance clause 5 shall be amended accordingly.
