AN ORDINANCE to accept and to apply the provisions of Determination 1 of 1950 intituled "A Determination to amend Determination VII Session 1921 providing for the payment of fares of members attending Sessions of the General Synod and for the allocation of the expenses of the Sessions of the General Synod" in the order and good government of the Church of England within the Diocese of Sydney.

WHEREAS Determination No. 1, 1950, intituled "A Determination to amend Determination VII Session 1921 providing for the payment of fares of members attending Sessions of the General Synod and for the allocation of the expenses of the Sessions of the General Synod" a copy whereof is contained in the Schedule hereto has been made by General Synod.

AND WHEREAS under Article No. 3 in the Schedule to the Church of England Constitutions Act Amendment Act of 1902 the Diocese may make ordinances upon and in respect of all matters and things concerning the order and good government of the Church of England and the regulation of its affairs within the Diocese.

AND WHEREAS by an Ordinance assented to on 21st June, 1876, regulating the method of accepting Determinations of General Synod it was provided that the mode of acceptance of such Determinations should be by Ordinance.

AND WHEREAS it is expedient to accept and to apply the provisions of the said Determination No. 1, 1950, as hereinafter expressed.

The Synod of the Diocese of Sydney in pursuance of its powers under the said Act hereby ordains and rules as follows:—

GENERAL SYNOD OF THE DIOCESES IN AUSTRALIA  
AND TASMANIA.

DETERMINATION I, SESSION 1950.

(Made 27th November, 1950.)

A DETERMINATION to amend Determination VII Session 1921 providing for the payment of fares of members attending Sessions of the General Synod and for the allocation of the expenses of the Sessions of the General Synod.

1. In Rule 6 of the Determination VII Session 1921 the first paragraph definition of "Cost of Fares" shall be repealed and the following substituted therefor:—

"Cost of Fares" means the actual sum paid by any member of Synod for the purpose of attending a Session of the General Synod in the purchase of tickets permitting him to travel by rail boat coach or air between his accustomed abode and the city in which the Session of the Synod is held, and shall include the expense of transport for such purpose incurred by a member who travels by any other means not exceeding in amount a sum approved by the Standing Committee and being not greater than that which might have been incurred in travel by rail boat coach or air.
