*Glebe Administration Ordinance Amendment  
Ordinance, 1962.*

No. 24, 1962.

AN ORDINANCE to amend the Glebe Administration Ordinance 1930 as amended to increase the number of corporators, of the Glebe Administration Board to empower it to act as a trustee of certain other lands to invest it with further powers of management and purposes incidental thereto.

WHEREAS by Ordinance No. 15, 1930 entitled "Glebe Administration Ordinance 1930" a Board consisting of seven persons of which not less than four were to be laymen was constituted to be known as "Glebe Administration Board" AND WHEREAS the said Board was by section 13 of the said Ordinance given absolute and full powers of managing and controlling the glebes therein referred to AND WHEREAS by the Church of England (Bodies Corporate) Act 1938 the members for the time being of the said Board were created a body corporate under the name of the "Glebe Administration Board" AND WHEREAS by virtue of Section 9 (1) (a) of the said Act all real and personal property which immediately before the commencement of the said Act was vested in or held by any person (including the Church of England Property Trust Diocese of Sydney) upon any trust for the management government or control of which the said Board was constituted was vested without any conveyance in the said Board but subject to Section 9 (2) (a) of the said Act. AND WHEREAS the said Act also empowers the Synod of a Diocese at whose instance the body corporate was constituted to make Ordinances for or in respect to the institution or organisation under the government or control of such body corporate or for or with respect to any church trust property vested in it including the power to fix the number of its members AND WHEREAS the said Ordinance No. 15, 1930 has been amended from time to time and it is expedient to further amend the same in order to increase the number of the corporators thereof to provide it with further functions and powers and to make certain other provisions incidental thereto NOW the Standing Committee of the Synod of the Diocese of Sydney in pursuance of the powers vested in it by the said recited Act, by the "Church of England (Bodies Corporate) Act 1938 Delegation of Powers Ordinance 1961" and in pursuance of the powers in that behalf conferred upon it by Church of England Trust Property Act 1917 and of all other powers thereunto it enabling **HEREBY ORDAINS DETERMINES DIRECTS AND RULES** as follows:-

1. This Ordinance may be cited as "Glebe Administration Ordinance Amendment Ordinance 1962."

2. (i) The "Glebe Administration Ordinance 1930" as amended by subsequent Ordinances is in this Ordinance referred to as the Principal Ordinance.

(ii) The Principal Ordinance as amended by this Ordinance may be cited as "Glebe Administration Ordinance 1930-1962."

3. The Principal Ordinance is amended as follows:-

(i) Clause 5 of the Principal Ordinance is amended as follows:-

By omitting the words "seven" and "four" and inserting in their place the words "nine" and "six" respectively.

(ii) By omitting from clause 8 the words "Three" and inserting in its place the word "five."

(iii) By omitting the whole of clause 9 and inserting the following clause in its place—

"9. There shall be a Chairman and a Deputy Chairman of the Board. The Board shall at its first meeting in each financial year appoint one of its members as Chairman and another as Deputy Chairman to preside at all meetings during the ensuing year and in the absence of such Chairman or Deputy Chairman may appoint from the members present one to act as Chairman of that meeting. The Chairman to have a deliberative but not a casting vote."

(iv) By inserting the following clause after clause 12;  
"12.a. The Board may be appointed to the office of trustee of any church trust property pursuant to any resolution of Synod or the Standing Committee thereof passed in that behalf provided that any such appointment shall not in any way alter or affect the trusts upon which the property or the rents profits and issues thereof may be held immediately prior to such appointment."

(v) By inserting after the word "Glebes" in clause 13 the following words—"or such other Church trust property of which it may be appointed a trustee."

4. The additional members of the Board provided for by Clause 3 (ii) hereof shall be elected by the Standing Committee within two months after this Ordinance has been assented to.

5. Notwithstanding any other provisions of the principal Ordinance the Chairman of the Board after this Ordinance comes into effect shall be the Most Reverend Hugh Rowlands Gough and the Deputy Chairman shall be Walter Samuel Gee Esquire.
