

# Parishes and Presentation and Exchange Ordinance Amendment Ordinance 1991

No 41, 1991

An Ordinance to amend the Parishes Ordinance 1979 and the Presentation and Exchange Ordinance 1988.

Whereas it is expedient to amend the said Ordinances.

Now the Synod of the Diocese of Sydney ordains as follows -

## Citation

1. This Ordinance may be cited as the "Parishes Ordinance and Presentation and Exchange Ordinance Amendment Ordinance 1991".

## Amendment to Parishes Ordinance

2. The Parishes Ordinance 1979 is amended -

(a) by omitting paragraph 6(a) and by inserting instead the following paragraph -

"(a) during the financial year preceding the date on which the proposal is received by the Standing Committee, from local revenues -

- (i) an amount has been paid as stipend to the minister which is not less than that part of the minimum stipend last recommended by the Synod for the rector of a parish which is required to be paid as stipend to the minister;
- (ii) the appropriate superannuation contributions have been paid in respect of the minister; and
- (iii) an adequate amount for travelling expenses has been paid to, or provided for the benefit of, the minister;"

(b) by omitting paragraph 8(1)(a) and by inserting instead the following paragraph -

"(a) the stipend and an adequate amount for travelling expenses (excluding any amount specified in relation to distance travelled) payable to, or required to be provided for the benefit of, the minister licensed to a parish; and"

## Amendment to Presentation and Exchange Ordinance

3. The Presentation and Exchange Ordinance 1988 is amended -

(a) by omitting clause 8(a)(i) and by inserting the following subparagraph -

- "(i) paid a stipend derived from local sources which was not less than that part of the minimum stipend recommended at the time

by the Synod or the Standing Committee which was required to be paid as stipend to the rector; and"

- (b) by inserting in clause 8(a)(ii) after the words "travelling allowance" the words ", or provided with a travel benefit,";
- (c) by omitting from clause 8(b)(ii) the words "part of the contributions" and by inserting instead the word "contributions";
- (d) by omitting clause 15(a)(i) and by inserting the following subparagraph -

(i) paid a stipend derived from local sources which was not less than that part of the minimum stipend recommended at the time by the Synod or the Standing Committee which was required to be paid as stipend to the rector; and"

- (e) by inserting in clause 15(a)(ii) after the words "travelling allowance" the words ", or provided with a travel benefit,";
- (f) by omitting from clause 15(b)(ii) the words "part of the contribution" and by inserting instead the word "contributions";
