
*Parramatta Anglican Regional Council Constitution
Amendment Ordinance 1972*

No. 37, 1972

AN ORDINANCE to amend clauses 2 and 4 (a) of the Parramatta Anglican Regional Council Constitution Ordinance and for purposes incidental thereto.

WHEREAS it has been deemed necessary to provide for in each parish a specific meeting of parishioners for the election of three lay parishioners who shall be electors for the purpose of the Parramatta Anglican Regional Council Constitution Ordinance 1971 and to determine more exactly who shall participate in such meetings NOW the Synod of the Diocese of Sydney in accordance with the powers vested in it by the Constitutions for the order and good government of the Church of England in Australia in the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) This Ordinance may be cited as "Parramatta Anglican Regional Council Constitution Amendment Ordinance 1972."

(2) The Parramatta Anglican Regional Council Constitution Ordinance 1971 is in this Ordinance referred to as the "Principal Ordinance."

(3) The Principal Ordinance as amended by this Ordinance may be cited as "Parramatta Anglican Regional Council Constitution Ordinance 1971-1972."

2. Sub-clause (e) of clause 2 of the Principal Ordinance is amended by adding after the word "as" the following words "an adult parishioner in clause 34 of," by omitting the word "in" where secondly occurring and by adding the words "as amended" after the figures "1971."

3. Sub-clause (a) of clause 4 of the Principal Ordinance is amended by deleting the whole of the first sentence of that sub-clause and substituting in its place the following:

"On the same day of the meeting in each parish summoned to elect Synod representatives as provided by the Church of England Constitutions Act Amendment Act of 1902 or at another time with the prior approval of the Bishop the minister shall constitute another meeting of parishioners according to clauses 32 and 34 of the Sydney Church Ordinance 1912-1971 as amended for the purpose of electing three lay parishioners who together with the minister shall be electors for the purpose of this Ordinance."

4. Clause 4 of the Principal Ordinance is further amended by adding a new sub-clause (d) as follows:

"(d) Notwithstanding any other provisions of this Ordinance or any existing Ordinance the first such election of three lay parishioners in each parish shall take place at such a meeting as provided in sub-clause (a) of this clause during the period 12 to 25 October, 1972, inclusive."
