
Presentation and Exchange Amendment Ordinance 1981

No. 41, 1981

AN ORDINANCE to amend the Presentation and Exchange Ordinance 1933-1975.

WHEREAS by Resolution No. 29 of 1980 the Synod of the Diocese of Sydney agreed that an amendment to the Presentation and Exchange Ordinance 1933-1975 be prepared by the Standing Committee to enable either the relevant area Bishop or the Archdeacon to be a member of a Presentation Board as chairman AND WHEREAS the Standing Committee has prepared the amendment NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) This Ordinance may be cited as the "Presentation and Exchange Amendment Ordinance 1981".
- (2) The Presentation and Exchange Ordinance 1933-1975 is referred to in this Ordinance as the "Principal Ordinance".

2. The Principal Ordinance is amended:—
 - (a) by inserting after clause 1 the following heading and clause:—

"Citation

1A. This Ordinance may be cited as the "Presentation and Exchange Ordinance 1933-1981".

- (b) by inserting in paragraph (c) of clause 3 after the word "An" the words "Assistant Bishop or an";
- (c) by omitting from clause 14 the words "the archdeacon of the archdeaconry in which the parish is situated" and by inserting instead the words "the Assistant Bishop exercising episcopal duties over that part of the Diocese in which the parish is situated or, where that Assistant Bishop declines to be a member of the Presentation Board, the archdeacon of the archdeaconry in which the parish is situated";
- (d) by inserting in paragraph (a) of clause 15 before the word "archdeacon" wherever occurring the words "Assistant Bishop or";
- (e) by inserting at the end of clause 16 the following words: "The responsibilities of the Archbishop under this clause may be delegated by him to the Assistant Bishop exercising episcopal duties over that part of the Diocese in which the parish is situated where the said vacancy has occurred".

3. A Presentation Board in existence under the Principal Ordinance immediately before the date of assent to this Ordinance may continue in existence after that date as if this Ordinance had not been enacted.
