
*Soldiers' Memorial Church of the Resurrection Cabramatta
Mortgaging Ordinance 1950 Amendment Ordinance 1951.*

No. 19, 1951.

AN ORDINANCE to amend the "Soldiers' Memorial Church of the Resurrection Cabramatta Mortgaging Ordinance 1950" to provide for the increase of the amount of advance authorised thereby.

WHEREAS by the "Soldiers' Memorial Church of the Resurrection Cabramatta Mortgaging Ordinance 1950" (hereinafter called the Principal Ordinance) the Church of England Property Trust Diocese of Sydney (therein and hereinafter called the Corporate Trustee) was authorised and empowered to mortgage the land comprised in the schedule to the said Principal Ordinance for the purpose of borrowing when the power was first exercised a sum not exceeding £1,250.

AND WHEREAS the said power has not yet been exercised.

AND WHEREAS owing to circumstances subsequent to the passing of the said Ordinance it has been found necessary and expedient to provide for a larger advance for the purposes set out in the Principal Ordinance. Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and declares as follows:—

1. This Ordinance may be cited as the "Soldiers' Memorial Church of the Resurrection Cabramatta Mortgaging Ordinance 1950 Amendment Ordinance 1951."

2. (a) The Soldiers' Memorial Church of the Resurrection Cabramatta Mortgaging Ordinance 1950" is in this Ordinance referred to as the Principal Ordinance.

(b) The Principal Ordinance as amended by this Ordinance may be cited as the "Soldiers' Memorial Church of the Resurrection Cabramatta Mortgaging Ordinance 1950-1951."

3. By reason of circumstances subsequent to the Trusts recited in the Principal Ordinance it is expedient to amend the same as hereinafter appears.

4. Clause 1 (i) (a) of the Principal Ordinance is amended by deleting the figures "£1,250" and inserting in their place the figures "£2,000."

And Clause 1 (i) (b) of the Principal Ordinance is amended by omitting all words therein appearing after the words "Provided that" and inserting the following words and figures:—

- (i) The amount first borrowed shall be reduced at the rate of not less than £100 per annum after the expiration of four years from the date of the exercise of the power.
- (ii) Any amount subsequently borrowed shall be reduced at such rate as the Standing Committee may by resolution determine.
