AN ORDINANCE to amend the St. Catherine's Clergy Daughters
School Ordinance 1922.

WHEREAS by the "St. Catherine's Clergy Daughters' School Endowment Ordinance of 1911" and the "St. Catherine's Clergy Daughters' School Ordinance 1922" it appears that on the twenty-second day of July one thousand nine hundred and twenty-two Two thousand six hundred and forty-nine pounds thirteen shillings and sixpence (£2649 13s. 6d.) was advanced in the manner therein referred to and the sinking fund in respect of such advance formed in pursuance of such Ordinance amounted to on that date the sum of One thousand eight hundred and twenty-seven pounds sixteen shillings and sixpence (£1827 16s. 6d.) so that on the said date there was a balance of Eight hundred and twenty-one pounds seventeen shillings (£821 17s. 0d.) still due in order to recoup to the Endowment Fund the advances and appropriations authorised by the said Ordinance AND WHEREAS on the 11th May 1923 the said sinking fund amounted to One thousand nine hundred and three pounds eight shillings and sixpence (£1903 8s. 6d.) and was applied and appropriated in part payment of the said advance of Two thousand six hundred and forty-nine pounds thirteen shillings and sixpence (£2649 13s. 6d.) leaving a balance of Seven hundred and forty-six pounds five shillings (£746 5s. 0d.) still due in order to recoup to the Endowment Fund the advances and appropriations authorised by the said last mentioned Ordinance AND WHEREAS on the said 11th May 1923 the assets of the said Endowment Fund exclusive of the said sum of Seven hundred and forty-six pounds five shillings (£746 5s. 0d.) the unpaid balance of the former advance as aforesaid amounted to the sum of Five thousand six hundred and eighty-one pounds four shillings and seven pence (£5681 4s. 7d.) AND WHEREAS further advances amounting to One thousand five hundred pounds (£1500) have been made in accordance with Section 18 of the said last mentioned Ordinance which together with the said sum of Seven hundred and forty-six pounds five shillings (£746 5s. 0d.) amounts to Two thousand two hundred and forty-six pounds five shillings (£2246 5s. 0d.) the amount at which the advance now stands AND WHEREAS on the 23rd June 1931 the assets of the said Endowment Fund exclusive of the said sum of Two thousand two hundred and forty-six pounds five shillings (£2246 5s. 0d.) the unpaid balance of the

former advance as aforesaid amounted to the sum of Four thousand one hundred and eighty-nine pounds fourteen shillings and one penny (£4189 14s. 1d.) AND WHEREAS on the 23rd day of June 1931 there were outstanding liabilities of the Council of the said School and it is expedient to authorise the said Council to appropriate a further sum not exceeding One thousand pounds (£1000) out of the said Endowment Fund for such purposes aforesaid and to make provision for the repayment to the said Endowment Fund of such sum together with the aforesaid balance of Two thousand two hundred and forty-six pounds five shillings (£2246 5s. 0d.) making in all a total amount not exceeding Three thousand two hundred and forty-six pounds five shillings (£3246 5s. 0d.) by payments of the said sum of not less than One hundred and fifty pounds (£150) per annum subject to the provisions hereinafter provided AND WHEREAS by reason of the hereinbefore recited facts it has become expedient to vary the trusts and directions contained in the hereinbefore recited Declaration of Trust and the hereinbefore recited Ordinances Now therefore the Standing Committee of the Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Church of England Trust Property Act 1917 and the Land Ordinance Procedure and Delegation of Powers Ordinance 1926 and in pursuance of the powers vested in the said Synod by the Constitutions for the management and good government of the Church of England within the State of New South Wales or otherwise in place of the said Synod directs declares and rules as follows:—

1. By reason of circumstances which have occurred since the creation of the hereinbefore recited Trusts it has become expedient to vary the Trusts.

2. Clause 18 of the said Ordinance of 1922 is hereby amended by deleting the words and figures One thousand five hundred pounds (£1500) and inserting in lieu thereof Two thousand five hundred pounds (£2500) and inserting at the end of the Clause the following words: "and for such other purposes as the Council of the said School may determine from time to time."

3. Clause 19 of the said Ordinance of 1922 is hereby amended by deleting the words and figures Two thousand three hundred and twenty-one pounds seventeen shillings (£2321 17s. 0d.) and inserting Three thousand two hundred and forty-six pounds five shillings (£3246 5s. 0d.),

4. Clause 20 of the said Ordinance of 1922 is hereby amended by adding the following words at the end of the said Clause: "Provided however the said Council may authorise the said Trust to postpone such payments for a period of five years from the 1st July 1930.

5. This Ordinance may be cited as the "St. Catherine's Clergy Daughters' School Ordinance (Amendment) 1931."
