*St. Catherine's School Waverley Amending Ordinance 1963*

No. 19, 1963.

AN ORDINANCE to amend the Constitution of the Council of St. Catherine's School, Waverley.

WHEREAS by the St. Catherine's Clergy Daughters' School Ordinance 1922 (hereinafter called "the Principal Ordinance") the Synod of the Diocese of Sydney constituted a Council of the said School AND WHEREAS the said Ordinance was amended by the St. Catherine's Clergy Daughters' School Further Amending Ordinance 1950 (No. 23, 1950) AND WHEREAS the name of the said School was altered to St. Catherine's School Waverley by the St. Catherine's Clergy Daughters' School (Change of Name and Council Incorporation) Ordinance 1955 (No. 22, 1955) AND WHEREAS it was declared in the said Ordinance No. 22, 1955 that such alteration should not prejudice or affect the continuity of the said Council AND WHEREAS it is desirable to vary the Constitution of the said Council NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of such Synod HEREBY ORDAINS AND DIRECTS as follows:-

1. Clause 3 of the Principal Ordinance is amended further
  - (a) by omitting the word "sixteen" in line four and inserting in lieu thereof the word "twenty";
  - (b) by omitting the word "twelve" in line five and inserting in lieu thereof the word "sixteen";
  - (c) by omitting the word "three" where first occurring in line five and inserting in lieu thereof the word "four";
  - (d) by omitting the word "three" when second occurring in line five and inserting in lieu thereof the word "eight";
  - (e) by omitting the word "six" in line six and inserting in lieu thereof the word "four";
  - (f) by adding the words "shall be a" following the word "one".
2. Clause 9 of the Principal Ordinance is amended
  - (a) by omitting the word "twelve" in line one and inserting in lieu thereof the word "sixteen";
  - (b) by omitting the word "one" in line three and inserting in lieu thereof the word "two";
  - (c) by omitting the word "two" in line three and inserting in lieu thereof the word "one".

3. This Ordinance may be cited as "St. Catherine's School Waverley Amending Ordinance 1963."

4. The Principal Ordinance as amended by Ordinance No. 23, 1950 and Ordinance No. 22, 1955 and this Ordinance may be cited as "St. Catherine's School Waverley Ordinance 1922-1963."
