
*St. Catherine's School Waverley (Mortgaging) Ordinance
Amendment Ordinance 1972*

No. 23, 1972

AN ORDINANCE to authorise the mortgaging of certain land situate at Bronte Road, Waverley and to amend the St. Catherine's School Waverley (Mortgaging) Ordinance 1971.

WHEREAS St. Catherine's School Waverley (Mortgaging) Ordinance 1971 (No. 11 of 1971 hereinafter called the "Principal Ordinance") consolidated in one Ordinance all the lands held and authorised to be mortgaged by the Council of St. Catherine's School Waverley, a Body Corporate under the Church of England (Bodies Corporate) Act 1938 (hereinafter called the "Council") AND WHEREAS the Council has recently acquired the land described in the Schedule hereto for the purposes of the said School AND WHEREAS it is expedient by reason of circumstances subsequent to the creation of the trusts to which the land described in the Schedule hereto is subject that such land should be mortgaged as hereinafter provided and also included within the provisions of the Principal Ordinance AND WHEREAS it is now expedient to amend the Principal Ordinance by the addition of the scheduled land NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES AND DIRECTS as follows:—

1. By reason of circumstances subsequent to the creation of the trusts to which the land described in the Schedule hereto is subject it is expedient that the said land or any part thereof should be mortgaged from time to time in such manner and to raise or secure the repayment of such monies as the Council shall from time to time determine and accordingly such mortgaging is hereby authorised.

2. It is expedient that the Principal Ordinance be amended by the addition of a further schedule described as the "Fourth Schedule" thereto of the land described in the Schedule hereto.

3. This Ordinance may be cited as "St. Catherine's School Waverley (Mortgaging) Ordinance Amendment Ordinance 1972".

4. The Principal Ordinance as amended by this Ordinance may be cited as "St. Catherine's School Waverley (Mortgaging) Ordinance 1971-1972".

SCHEDULE

ALL THAT piece or parcel of land situated at Waverley in the Municipality of Waverley Parish of Alexandria and County of Cumberland being Lot A in Plan Annexed to Transfer No. B535065

having a frontage to Bronte Road (formerly Leichhardt Street) of about 31' 6" by a depth on one side of about 208' 7" and on the other of about 223' 6" and a rear line of about 31' 5" and being the whole of the land in Certificate of Title Volume 4074 Folio 94.
