

**SYDNEY ANGLICAN HOME MISSION SOCIETY (SYDNEY CHURCH OF ENGLAND NEW AREAS COMMITTEE) ORDINANCE 1986**

NO. 45, 1986

AN ORDINANCE to effect transfer of the functions, assets and liabilities of the Sydney Church of England New Areas Committee to the Sydney Anglican Home Mission Society, to repeal the Sydney Church of England New Areas Committee Constitution Ordinance 1967 and to deal with various related matters.

**WHEREAS:**

A. By the Sydney Church of England New Areas Committee Constitution Ordinance 1967 a committee of the Synod of the Diocese was constituted (which committee is herein called "the NAC"). 5

B. Hitherto the properties set out in the Schedule hereto (which properties are herein called the "Properties") have been managed and controlled by or on behalf of the NAC.

C. There have been consultations between the NAC and the Council referred to in the Sydney Anglican Home Mission Society Ordinance 1981 and constituted a body corporate under the Bodies Corporate Act, (herein called "HMS") as a result of which it has been agreed that the NAC should be discontinued and that the powers duties and functions of the NAC as set forth in the Sydney Church of England New Areas Committee Constitution Ordinance 1967 be assumed by HMS. 10

D. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the Properties and each of them are held it is inexpedient to carry out and observe the same and it is expedient that the Properties and each of them be held upon the trusts hereinafter declared. 20

E. It is expedient by reason of circumstances which have arisen subsequent to the creation of the trusts upon which all the assets and liabilities held by or on behalf of the NAC (except for the Properties) that such assets and liabilities be transferred to and be vested in HMS. 25

NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:

1. This Ordinance may be cited as the "Sydney Anglican Home Mission Society (Sydney Church of England New Areas Committee) Ordinance 1986".
2. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the Properties and each of them are held it is inexpedient to carry out and observe the same and it is expedient that the Properties and each of them which have heretofore been respectively held by the Property Trust upon trust for the NAC or its objects or on any other trust shall henceforth be held by the Property Trust upon trust for HMS to be held and applied in providing a pastoral ministry in areas which by reason of rapid increase in population are or were unable in their early development to support a ministry. 5 10
3. HMS shall be responsible for the management and control of the Properties. 15
4. All assets of the NAC (except the Properties) heretofore held by the NAC or on its behalf shall be transferred to and vested in HMS to be held and applied subject to the Sydney Anglican Home Mission Society Ordinance 1981. Such assets as cash and investments shall be held subject to the trusts created by clause 2. 20
5. Property passing pursuant to all gifts, bequests, settlements and devises to or for the benefit of the NAC shall pass to HMS to be held subject to any particular or specific trust applicable thereto. 25
6. All liabilities and obligations of the NAC under any arrangement, contract, agreement or trust, whether of employment or otherwise, shall be assumed by HMS which shall comply with, observe and perform the same to the full extent of the obligations of the NAC thereunder. 30
7. A reference in any other ordinance to the NAC shall be read and construed as a reference to HMS.


8. The Sydney Church of England New Areas Committee Constitution Ordinance 1967 is hereby repealed.




