AN ORDINANCE to supplement the Sydney Church of England Girls' Grammar School Mortgage Ordinance 1954 (No. 18/1954).

WHEREAS by Ordinance entitled "Sydney Church of England Girls' Grammar School Ordinance 1954" (No. 18/1954) the Sydney Church of England Girls' Grammar School Council (hereinafter called "the Council") was empowered to mortgage from time to time the lands described in the first second and third schedules thereto and to apply the moneys so raised for the use benefit and purposes of the Schools established or proposed to be established by the Council or any one or more of them in such manner as the Council should from time to time determine AND WHEREAS since the passing of the said Ordinance the Council has acquired for its purposes further lands and premises namely that set out in the schedule hereto AND WHEREAS it is expedient that the power of mortgaging given by the said recited Ordinance be extended to such land NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY DIRECTS AND ORDAINS as follows:—

1. By reason of circumstances which have arisen subsequent to the acquisition of the lands described in the schedule hereto it is expedient that the provisions of clauses 2 and 3 of Ordinance No. 18, 1954, shall apply to such lands and accordingly the said provisions shall apply thereto in like manner as to the lands described in the first second and third schedules to such ordinances.

2. This Ordinance may be cited as "Sydney Church of England Girls' Grammar School Mortgage Ordinance, 1968".

SCHEDULE

All that property known as "Wilkinson House" number 167 Forbes Street, Darlinghurst situated in the City of Sydney Parish of Alexandria County of Cumberland having a frontage of 53' 11½" to St. Peter's Street by a depth along Forbes Street of 90' 10½" and being the whole of the land in Certificate of Title Volume 7240 Folio 231.

All that property known as numbers 176-190 Bourke Street, Darlinghurst in the City of Sydney aforesaid having a frontage of 107' 6" to Bourke Street by irregular depths being Lots 5, 6 and 7

and part of Lots 4 and 8 of Section 6 of Edward Deas Thomson's Subdivision and the whole of the land in Certificate of Title Volume 7117 Folio 131.

All that property known as numbers 192-204 Bourke Street, Darlinghurst aforesaid having a frontage of 112' 6" to Bourke Street being Lots 9, 10 and 11 and part of Lot 8 of Section 6 of Edward Deas Thomson's Subdivision and also 15 perches or thereabouts being part of Block 24 (new Grant) of the Riley Estate and all being the whole of the land in Certificate of Title Volume 5140 Folio 133.

All that parcel of land situated at Cremorne in the Municipality of North Sydney Parish of Willoughby County of Cumberland having a total frontage of 90' 9½" to Waters Road and Gerard Street with irregular other dimensions more particularly described as Lot 1 D.P.222013 and the whole of the land in Certificate of Title Volume 9747 Folio 8 and known as number 29 Waters Road, Cremorne.

All that parcel of land situated at Cremorne aforesaid having a frontage of 46' to Waters Road by depth of about 165' 9½" on the north and 167' 10" on the south being the whole of the land in Certificate of Title Volume 7134 Folio 127 and known as number 21 Waters Road, Cremorne.

All that parcel of land situated at Cremorne aforesaid having a frontage of about 39' 11" to Waters Road by a depth of about 140' 10½" on the south 140' 9" on the north and rear width of 36' 9" being part of Lot 11 Redlands Estate and the land described in Conveyance Registered No. 319 Book 2674 and known as number 23 Waters Road, Cremorne.

All that parcel of land situated at Cremorne aforesaid having a frontage of 16' to Gerard Street and depth of about 181' 8½" being part of Redlands Estate and the land described in Conveyance No. 232 Book 2435.
