
*Sydney Church of England Investment Trust
Incorporation Ordinance 1967*

No. 1, 1967.

AN ORDINANCE to authorise the incorporation of "Sydney Church of England Investment Trust" as a Body Corporate pursuant to the provisions of the Church of England (Bodies Corporate) Act 1938.

WHEREAS by Ordinance No. 36, 1965 entitled "Sydney Church of England Investment Trust Constitution Ordinance 1965" the Synod of the Diocese of Sydney formed and constituted the body designated as "Sydney Church of England Investment Trust" for the better investment of funds being Church Trust Property in the Diocese of Sydney and pooling of separate Church Trust Properties and for averaging gains, losses and interests and purposes related thereto and by the said Ordinance provided that the said body should consist of not more than seven nor less than three Commissioners being laymen and members of the Church of England in Australia having an active affiliation with that Church AND WHEREAS by the Church of England (Bodies Corporate) Act 1938 Delegation of Powers Ordinance 1961 the Synod of the Diocese of Sydney appointed the Standing Committee of such Synod as the Committee to exercise from time to time during the recess of Synod certain powers authorities duties and functions of Synod conferred upon it by the said Act including the constitution of a Body Corporate in pursuance of Section 4 of the said Act AND WHEREAS it is expedient for the better carrying on of the functions of the Sydney Church of England Investment Trust as constituted by the said Ordinance No. 36, 1965 that it be constituted a Body Corporate as provided by the said Act NOW the Standing Committee of the Synod of the Diocese of Sydney in pursuance of the powers vested in it by virtue of the Church of England (Bodies Corporate) Act 1938 Delegation of Powers Ordinance 1961 HEREBY ORDAINS DIRECTS AND RULES as follows:-

1. The Standing Committee of the Synod of the Diocese of Sydney hereby declares that it is expedient for the purpose of controlling managing governing and carrying on the functions and objects for which Sydney Church of England Investment Trust was constituted as an organisation of the Church of England in Australia in the Diocese of Sydney pursuant to Ordinance No. 36, 1965 that the persons who for the time being are the Commissioners duly appointed to constitute manage and control the said Trust should be constituted a Body Corporate under the name of "Sydney Church of England Investment Trust."
