

**SYDNEY DIOCESAN SUPERANNUATION FUND AMENDMENT ORDINANCE 1991**

No 28, 1991

An Ordinance to amend the Sydney Diocesan Superannuation Fund Ordinance 1961 (the "Principal Ordinance").

Whereas it is expedient to amend the Principal Ordinance.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains as follows.

1. This Ordinance may be cited as the "Sydney Diocesan Superannuation Fund Amendment Ordinance 1991".

2. Clause 13 of the Principal Ordinance is amended -

(a) by omitting the first word "The" from subclause (1) and by inserting instead the words "Subject to clause 13(1A) the".

(b) by inserting a new subclause 13(1A) after subclause 13(1) -

"(1A) If the Standing Committee determines that the contributions are to be paid in respect of any period other than a calendar year the contribution payable during that period in respect of each Member shall be the percentage last determined by the Synod or the Standing Committee by resolution of the minimum annual stipend or salary recommended by the Synod or Standing Committee in respect of the Member or the class of persons to which the Member belongs and applying on the first date of that period."

(c) by inserting the words "or clause 13(1A)" after the words "clause 13(1)" in subclause (2).

(d) by inserting the words "between all or any one or more of such sources" after the words "in such proportions as" in subclause (2).

(e) by inserting the following sentence at the end of subclause (2) -

"The Synod or the Standing Committee from time to time shall determine the proportion of contributions made pursuant to paragraphs (b) and (c) which are to be regarded for the purposes of this Ordinance as contributions of the Member, in addition to all contributions made pursuant to paragraph (a)".

(f) by inserting the words "(if any)" after the word "contributions" where it first appears in subclause (3).

(g) by inserting the words "(except those contributions made under paragraphs (b) and (c) of clause 13 (2) which are to be regarded as contributions of the Member)" after the word "Parish" where it appears for the second time in the second sentence of subclause (4).

(h) by inserting the words "(if any)" after the word "contributions" in subclause (6)(a).

(i) by inserting the words "or in respect of" after the words "payable by" where it first appears in subclause 10.

3. Clause 14 of the Principal Ordinance is amended -

(a) by omitting the words "in respect of that Member" from subclause (2) where secondly appearing and by inserting the following words instead -

"by or in respect of that Member (after such adjustment as, in the opinion of the Board, is equitable in respect of any tax imposed on any contributions made from sources designated by Synod or the Standing Committee or by a Parish, Organisation or missionary society and to be regarded as contributions of the Member pursuant to clause 13(2))."

(b) by inserting after the word "Member" where it first appears in subclause (3)(c)(ii)(A), the following words -

"(including those contributions to be regarded as contributions of the Member pursuant to clause 13(2) after such adjustment as, in the opinion of the Board, is equitable in respect of any tax imposed on any such contribution)".
