
*Synod Representative and Parishes and
Provisional Districts Amending Ordinance 1970*

No. 55, 1970

AN ORDINANCE to further amend the Synod Representative Ordinance 1945-1958 and the Parishes and Provisional Districts Ordinance 1961-1970.

The Synod of the Diocese of Sydney in pursuance of the powers conferred upon it by the Constitutions Act Amendment Act of 1902 for the management and good government of the Church of England in Australia within the State of New South Wales hereby ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (a) This Ordinance may be cited as "Synod Representative and Parishes and Provisional Districts Amending Ordinance 1970".
(b) The Synod Representative Ordinance of 1945-1958 is in this Ordinance referred to as the "Principal Ordinance".
(c) The Principal Ordinance as amended by this Ordinance may be cited as "Synod Representative Ordinance 1945-1970".
(d) The Parishes and Provisional Districts Ordinance 1961-1967 as amended by this Ordinance may be cited as "Parishes and Provisional Districts Ordinance 1961-1970".
2. The Principal Ordinance is amended by inserting next after sub-clause (2) of Clause 1 the following new sub-clauses (3) and (4):
"(3) A Provisional District formed under the provisions of the Parishes and Provisional Districts Ordinance 1961-1967 shall be deemed a separate cure of souls for the purpose of Synod representation. Provided that no such meeting as aforesaid in a Provisional District shall choose more than one representative.
"(4) A New Housing District formed under the provisions of the Parishes and Provisional Districts Ordinance 1961-1967 shall be deemed a separate cure of souls for the purpose of Synod representation. Provided that not more than one Resident Minister of such District shall be summoned to Synod and the Minister so summoned shall convene such meeting as aforesaid and no such meeting as aforesaid shall choose more than one representative."
3. The Parishes and Provisional Districts Ordinance 1961-1967 is amended:
(a) by omitting from Clause 10 the words "within the meaning of the Constitutions".
(b) by omitting the proviso to Clause 12.
