

Wollongong Zone Council Amendment Ordinance 1983

AN ORDINANCE to amend the Wollongong Zone Council Ordinance 1972-1981.

WHEREAS

A. By resolution No. 29 of 1982, the Synod of the Diocese of Sydney resolved:—

- (a) to change the name of the Wollongong Zone Council to the Wollongong Anglican Regional Council; and
- (b) that without prejudice to any possible future division of the Diocese, the Rural Deanery of Sutherland should be included in the oversight of that Council.

B. It is expedient to amend the Wollongong Zone Council Ordinance 1972-1981 and various other Ordinances accordingly.

NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) This Ordinance may be cited as the "Wollongong Zone Council Amendment Ordinance 1983".

(2) The Wollongong Zone Council Ordinance 1972-1981 is referred to in this Ordinance as the "Principal Ordinance".

(3) The Principal Ordinance as amended by this Ordinance may be cited as the "Wollongong Anglican Regional Council Ordinance 1972-1983" and in any re-print of that Ordinance clause 14 shall be amended accordingly.

2. Clause 2 (c) of the Principal Ordinance is amended by deleting the word "Zone" and inserting the words "Anglican Regional".

3. Clause 2 (g) of the Principal Ordinance is amended by deleting all the words appearing therein and inserting the following:—

"Region" means that part of the Diocese over which the Bishop exercises episcopal oversight.

4. Clauses 2, 3, 4 and 11 of the Principal Ordinance are amended by deleting the word "Zone" wherever it appears and inserting the word "Region".

5. Clause 2 (b) of the Principal Ordinance is amended by deleting the word "in" and inserting the word "of".

6. Clause 3 (b) of the Principal Ordinance is amended by deleting the words "in Wollongong".

7. Clause 20 of the Delegation of Powers and Ordinance Procedure Ordinance 1973 (as amended) is amended by deleting the words "other than the Rural Deanery of Sutherland".

8. Clause 1 (3) of the Parishes Ordinance 1979 is amended:—

(a) by omitting the words "Zone" and inserting the word "Region"; and

(b) by omitting the words "Wollongong Zone Council" and inserting the words "Wollongong Anglican Regional Council".

- (a) by omitting the word "Zone" and inserting the word "Region";

 - (b) by omitting the words "Wollongong Zone Council" and inserting the words "Wollongong Anglican Regional Council".

10. The Macarthur Regional Anglican Church School Ordinance 1982 is amended:—

- 30
- (a) by deleting sub-clause 2 (j) and inserting the following:—
 - (j) "Regional Council" means the Wollongong Anglican Regional Council as constituted by the Wollongong Anglican Regional Council Ordinance 1972 as amended;
 - (b) and by deleting the word "Zone" wherever it appears in clauses 3, 12 and 17 and inserting the word "Regional".
